(hereafter Pioneer) will be to make this product of being operated for the ordinary purposes for which this product is used without charges for labor and parts to the purchaser, and subject to the following conditions:

1. The malfunction is proved attributable to a defect in construction or workmanship, including repairs performed under this warranty. Malfunction for any other reason—including but not limited to misuse, negligence, accident, or tampering with parts—will not be remedied under this warranty.
2. All warranty repairs must be performed at an approved Pioneer warranty station (a partial listing of such warranty stations is included in a separate document enclosed herewith, but such listing is subject to change without notice so purchaser should also check a local telephone directory) or, if so requested by purchaser in writing, as Pioneer otherwise may direct in writing. Purchaser must retain the purchase receipt and present it with this certificate as proof of ownership and entitlement to warranty repairs. Unauthorized repairs will not be compensated by Pioneer, are not the responsibility of Pioneer, and if such repairs damage this product, such damage is not remediable under this warranty.
3. Purchaser shall bear all shipping, packing and insurance costs and all other costs, excluding labor and parts necessary to effectuate repairs under this warranty.
4. Periodic checkups, voltage and/or cycle conversions are not covered by this warranty.
1. **This warranty is in lieu of all other express warranties which now or hereafter might otherwise arise with respect to this product. Any and all Implied Warranties, including the warranties of mercantability and fitness for particular purpose, shall have no greater duration than the duration period for the express written warranty applicable to this product, as shown above, and shall terminate automatically at the expiration of such duration period.
